- HEREBY WAIVE AND RELEASE any right, claim or cause of action of any kind whatsoever arising out of or as a result of participation in the Activity which I may have or which may arise against the sanctioning organization(s), their administrators, directors, agents, officers, members, volunteers, and employees, other participants, officials, rescue personnel, sponsors, advertisers, owners and lessees of the premises on which the Activity is conducted which includes but is not limited to the GREATER ROCKFORD AIRPPORT AUTHORITY and its directors, agents, officers, and employees, or any other corporate entity which may afford me an occasion or opportunity to observe or participate in any activity arising out of the Activity (each of the forgoing shall be considered one of the "RELEASEES" herein). I FURTHER ASSUME any and all risk and waive and release any and all causes of action or rights against RELEASEES and their agents, servants, employees, subsidiaries or affiliates, which might accrue to me due to any accident involving Releasees, regardless of any question of negligence on the part of Releasees. I FURTHER AGREE that if, despite this AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, HOLD HARMLESS AND DEFEND EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may be incurred as the result of such claim.

I ACKNOWLEDGE THAT I AM OVER THE AGE OF 18 YEARS, HAVE READ THIS AGREEMENT AND FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE, AND I INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID, THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
